## Business User Member Application and Agreement

### My Personal Application

I, the applicant named on this application ('the Applicant'), hereby apply to become a member of East Devon Alive Private Members Association (EDA PMA) - ('the Association').

### My Agreement With The Association

#### Terms used in this Agreement have the following meanings:

- '**Association's Constitution**' - mean the Association's: Constitution, Core Values and Principles and Members Acceptable Conduct.
- '**Business User**' means: a member specialising and practicing in one or more of the Services strictly in the private only at all times within the Association.
- '**Contract**' means: a particular arrangement between at least two Members.
- '**Guiding Members**' mean: the founding members and current regional representatives of the Association.
- '**Issues Arising**' mean: conflicts, complaints, wrong doings or other matters of which the Applicant may become aware.
- '**Members**' means: other members of the Association seeking Services.

- To honour this agreement and any agreements I may enter into with Members, and (where applicable) the Association's Constitution.
- To be honourable, equitable, transparent, and open in everything I do.
- To act reasonably and proportionately according to any circumstances I might face.
- To encourage calm debate, without censoring.
- To act with self-autonomy (i.e., self-governing).
- To accept decisions made by the Guiding Members.
- To immediately report any Issues Arising to the Guiding Members.

- **To Keep All Practices, Dealings And Other Matters I May Conduct Within The Association Strictly Within The Private Realm Only And Within The Association.**
- **Not To Seek, Commence Or Pursue Any Matter Against The Association And Its Members** through any Courts, Tribunals or otherwise (be they in the private or public realm).

## **2. My Dealings with the Association and Its Members:**

- To treat all Members with respect and kindness valuing diversity and different points of view.
- To be open and honest about realistic outcomes (where appropriate).
- To ensure Members are always given the best possible advice to promote informed choices.
- To always endeavour to do my best.
- To encourage Members to take personal responsibility.
- To respect the privacy of Members - only sharing information with their express permission.

## **3. My Personal Responsibilities:**

### **To Take And Accept Personal Responsibility For:**

- My own decisions and actions.
- Managing and taking control of my own practices without the need for insurance and registration of any kind.

## **4. My Contributions:**

- **To donate:**
  - Subscriptions or other contributions to the Association.
  - Any money or any alternative form of 'payment' as may be agreed directly with any Members for any services and/or goods I may receive.

- To stand under natural and common laws, and rules of equity.

- To become self-sufficient and independent from control of all description.
- Wherever possible to support and assist the Association in its efforts to build and establish healthy communities in the private.

- I may choose not to be licensed, registered, and/or regulated under any public authority of any kind.
- I may choose not to participate in any relevant insurances.

## **7. My Acknowledgement and Understanding:**

- It is in my interest to be educated in and to promote Natural Law and Sovereignty, Equity and Privacy.
