## Community User Member Application and Agreement

### My Personal Application

I, the applicant named on this application ('the Applicant'), hereby apply to become a member of East Devon Alive Private Members Association (EDA PMA) - ('the Association').

### My Agreement With The Association

#### Terms used in this Agreement have the following meanings:

- **'Association's Constitution'** – means the Association's: Constitution, Core Values and Principles and Members Acceptable Conduct.
- **"Business Users"** mean: members of the Association who practice in or provide any one or more of the Services in the private only.
- **'Contract'** means: a particular arrangement between at least two Members.
- **'Guiding Members'** mean: the founding members and current regional representatives of the Association.
- **'Issues Arising'** mean: conflicts, complaints, wrong doings or other matters of which the Applicant may become aware.
- **'Members'** mean: other members of the Association including Business Users.
- **'Services'** - mean: education, health assessments, benefits, therapies, treatments, farming, products and all other services, provided or offered within the Association.

### I, the Applicant, Hereby Declares:

#### 1. My Agreement and Commitment:

- To strive at all times to cause no harm, no loss, and no injury.
- To treat all Members with respect and kindness.
- To honour this agreement and any agreements I may enter into with the Members, and (where applicable) the Association's Constitution.
- To be honourable, equitable, transparent, and open in everything I do.
- To respect and protect: the rights, privacy and property of the Association and its Members.
- To act reasonably and proportionately according to any circumstances I might face.
- To value diversity and different points of view.

- To encourage calm debate, without censoring.
- To act with self-autonomy (i.e., self-governing).
- To accept decisions made by the Guiding Members.
- To immediately report any Issues Arising to the Guiding Members.
  
- **To Keep All Practices, Dealings And Other Matters I May Conduct Within The Association Strictly Within The Private Realm Only And Within The Association.**
  
- **Not To Seek, Commence Or Pursue Any Matter Against The Association And Its Members** through any Courts, Tribunals or otherwise (be they in the private or public realm).

## 2. My Personal Responsibilities:

### To Take And Accept Personal Responsibility For:

- My own decisions and actions, including decisions I may make based on any risks disclosed by the Business Users.
- My own health and wellbeing, my own lifestyle, and my own choices.

## 3. My Willingness:

- To stand under natural and common laws, and rules of equity.
- To be at peace, love and harmony with the Members.

## 4. My Acknowledgement and Understanding:

- Business Users:
  - practice and/or provide Services in the private only;
  - may not be licensed, registered, and/or regulated under any public authority of any kind; and
  - may not participate in any relevant insurances.
- Any Services:
  - I may receive may not be covered by my own personal insurances; and
  - may not, necessarily, conform to the same services provided in the public realm.
- None of the Services is foolproof.
- It is in my interest to be educated in Natural Law, Sovereignty, Equity and Privacy.
- Contract relations only exist between myself and the Members.
- My informed consent may only be given in my own personal discussions with the relevant Business Users.
- None of my personal data, medical and/or other records shall be released or shared without my express written consent.
- This entire Agreement only relates and applies to all Services and other matters carried out within the Association itself.
- I may withdraw from this entire Agreement at any time (subject to honouring any ongoing obligations contained in this Agreement).

- ✓ I have read, fully understand and will honour this entire Agreement and also the Association's Constitution made available to me.
- ✓ Any questions I have asked have been answered fully to my satisfaction.
- ✓ I enter into this Agreement of my own free will and/or on behalf of my dependent, without any pressure or promise of care or other Services.
- ✓ This document represents my entire agreement with and for becoming a member of the Association, and supersedes any previous agreement.
